Application and development strategy of color aesthetics in modern film

This problem of excessive use of color reflects the lack of deep understanding of color aesthetics among some directors, and they fail to truly understand the laws of color expression. At the same time, they may also focus too much on commercial factors, hoping to attract audiences through visual stimulation, but ultimately may affect the artistic quality of the film, thereby damaging the reputation of the director and the film.

4 The development strategy of modern film color aesthetics

4.1 Innovate the way of using color

In order to promote the development of color aesthetics of modern film, the directors of modern film need to have the courage in the application of color, break through the traditional color collocation mode, and explore the new combination of color and narrative. First, break the inherent color pattern and try to use some unconventional color combinations, such as complementary colors and contrasting colors, in order to create a novel, unique visual effect. At the same time, they can also learn from the color application experience of other art categories, such as painting, photography, etc., to absorb the creative elements and enrich the expression techniques of film color. Second, deeply study the relationship between color and narrative, and explore the new role of color in narrative. Try to use color to express the inner world of the characters, or to use color changes to suggest the development of the plot. Use color as a symbolic technique, using a specific color as a metaphor for a certain emotion or theme. Through these innovative ways of color application, we will bring a new visual experience to the audience and improve the artistic expression of the film. These innovations can also help to expand the boundaries of color aesthetics and inject new vitality into the film art. 4.2 Strengthen the coordination between color and narrative

For example, when a character moves from despair to hope, the director can express this psychological process by gradient of color, such as from dark to light. When a character is faced with a major choice, the director can express his inner contradictions and struggles through the contrast of colors, such as the interweaving of warm colors and cold colors. Through the coordinated use of color and narrative, color can truly become a powerful tool for emotional expression, bringing more intuitive and shocking audio-visual experience to the audience. This coordination also helps to improve the overall quality of the film, so that the color and other film elements form an organic unity, and jointly serve the theme expression of the film. Modern films should constantly explore the combination of color and narrative, accumulate experience and summarize the rules in practice, constantly improve their color control ability, and contribute more perfect and more moving film art masterpieces for the audience.

4.3 Reasonable control of color use intensity

Modern film color aesthetics needs to reasonably control the use intensity of color, avoid the excessive use of color, and adjust the color intensity according to the narrative rhythm to achieve the best visual performance effect. According to the overall style and rhythm of the film, it is need to grasp the measurement of color use, to avoid the situation of color flood. In some scenes that need to render atmosphere and enhance emotion, the saturation and lightness of color can be appropriately increased to make the picture more vivid. Conversely, in some scenes that need calm and rational expression, the saturation and lightness of color can be appropriately reduced to make the picture more composed and introverted. According to the rhythm and fluctuations of the narrative, dynamically adjust the intensity of color. At the moment of narrative climax and emotional explosion, the visual impact and emotional expression can be enhanced by strong color contrast and vivid change; at the moment of narrative trough and emotional flattening, the color harmony and soft transition can be used to relieve visual fatigue and create a comfortable viewing atmosphere. Through the reasonable color intensity control, the color can really become a powerful assistant of the narrative, rather than the burden of the vision. This control also helps to improve the artistic taste of the film and avoid the overall quality of the film affected by the improper use of colors. Modern films should continue to explore and summarize in the creative practice, achieve moderation, purpose and strategy in the use of color, and strive to achieve a perfect balance between visual impact and artistic taste, so as to contribute more exquisite and moving film art masterpieces for the audience.

5 Conclusion

The development of modern film color aesthetics requires directors to explore and practice in three aspects of innovation, coordination and control. It needs to break through the traditional color collocation mode, explore the new combination of color and narrative, strengthen the correlation between color and narrative, grasp the measurement of color use, dynamically adjust the color intensity, and achieve a balance between visual impact and artistic taste. As an important expression element of film art, the development of color requires directors to have the courage to try, be good at summarizing, deepen their understanding of color aesthetics in theoretical research and creative practice, and improve their ability of color control. At the same time, it also needs the whole film industry to create a good creative environment and provide necessary support.
